CITATION:

For heroic achievement in connection with combat operations against the enemy as an Assault Team Leader for a Joint Task Force in support of Overseas Contingency Operations from 28 to 29 January 2017. During this period, Senior Chief Petty Officer Owens displayed courageous combat leadership and incredible operational insight as a Team Leader in charge of a five-man assault team directed to execute a President of the United States approved contingency operation, which resulted in 35 enemy fighters eliminated, including several senior enemy commanders directly responsible for lethal attacks on coalition forces in the Arabian Peninsula. Senior Chief Petty Officer Owens served as an assault team leader for a Special Operations element targeting senior Al Qaeda leadership in Rawdat Athabah, Bayda Governorate, Yemen. He directed his team during an arduous dismounted patrol to the target objective. Without any regard for his own safety, and as the assault force came under withering enemy fire, Senior Chief Petty Officer Owens selflessly exposed himself to the attack, and courageously led his team's assault on the enemy stronghold. While maneuvering towards the enemy compound, Senior Chief Petty Officer Owens was mortally wounded by enemy fire. His courageous actions undoubtedly ensured mission success by regaining critical momentum for the assault force during the raid. By his extraordinary guidance, zealous initiative, and total dedication to duty, Senior Chief Petty Owens reflected great credit upon himself and upheld the highest traditions of the United States Naval Service.
